### About Miracles for Kids:

Miracles for Kids is a 501(c)(3) nonprofit organization serving families with critically ill children receiving treatment at one of four affiliate hospitals: CHOC Children's in Orange, Children's Hospital Los Angeles, Mattel Children's Hospital UCLA, and Benioff Children's Hospital in the Bay Area. By operating programs that provide financial aid, basic needs, and wellness to patients and their families, Miracles for Kids creates stability when families are crumbling from the financial and emotional devastation of fighting for their child's life. Founded in 2002, Miracles for Kids operates an office in Irvine, CA and a subsidized apartment complex, Miracle Manor, in Orange, CA.

### Job Overview:

The therapist will provide culturally competent mental health services to individuals and families who are experiencing varying levels of difficulties due to a child being diagnosed with a life-threatening illness. The therapist will use a trauma focused model in combination with psychotherapy to decrease levels of depression and anxiety, and to teach skills to manage stress. The therapist will collaborate with LCSW who will oversee recruitment and supervision of MSW interns and MFT's.

### Job Duties:

- Provide high quality, compassionate and ethical mental health therapy to clients as scheduled.
- Provide weekly counseling services to families and individuals.
- Facilitate social skill classes to both adult and children at Miracle Manor and main office.
- Facilitate quarterly movie nights.
- Attend monthly staff meetings in person when available.
- Stay current with updated research and best practices, specifically regarding the trauma focused models and psychotherapy.
- Secure client information per HIPAA standards.
- Complete initial assessment to obtain information concerning social history, treatment, and other pertinent information to determine eligibility for ongoing therapy.
- Plan and administer therapeutic treatment, behavior modification techniques, and stress management skills.
- Consult with psychiatrist or other specialists concerning treatment plans and amend plans on an as needed basis, understanding that Miracle for Kids does not diagnose clients but refers out for service.
- Maintain statistics to be used in grant proposals.
- Provide weekly stat report.
- Provide clinical progress notes using a data base.
- Be available to conduct in-home services.
- Consult with Programs team when necessary, regarding conflict resolution, crisis management, or other situations that arise and staff require training or direction.
- Complete all recommended licensure hours to become a Licensed Clinical Social Worker or a Licensed Marriage and Family Therapist as well as continuing education requirements as outlined by the National Association of Social Workers or the Board of Behavioral Sciences.
